

Select the record you want to transfer and click Continue.	4
Start the service: Review the terms and requirements, then agree and click Apply for the service.	5
Select the Trademark Retention status and click Continue.	6
Fill in the data of the new business owner and click on Save. Write the mobile number and email, add the national address, attach a photo of the ID, and click on Continue.	7
Review the application summary, confirm the accuracy of all entered data, and click (Submit Application).	8

Conditions and Requirements

- The commercial registration must be active.
- The new owner must not have a commercial registration for a sole proprietorship.
- The new owner must not be a government employee and must be at least 18 years old.
- The commercial registration name must not be in the personal name of the transferor.
- The following must be verified if the person is deceased:
 - A certificate of inheritance must be provided.
 - If there are minors involved, a guardianship certificate is required.
 - A legal power of attorney from all heirs stating the transfer of the establishment must be submitted.
 - A sale and transfer contract from the heirs must be provided, indicating the registration number.


